## Sampling Activities Planned for the Week of August 22, 2016, at Ascon Landfill Site in Huntington Beach

**Why This Notice?** Our agency, the Department of Toxic Substances Control (DTSC), is the lead agency for the cleanup at the Ascon Landfill site located at the southwest corner of Hamilton Avenue and Magnolia Street in Huntington Beach. In June 2015, DTSC certified the Final Environmental Impact Report (EIR) and approved the final cleanup remedy known as the Remedial Action Plan (RAP) for the site.

This planned sampling work is to support the future remedial action for the site. ***Work will take place on the east side of the site at and adjacent to Pit F near Magnolia Street and be conducted Monday through Friday, 7 am to 5 pm for about one (1) week.*** You will see site workers and necessary field equipment needed to collect samples.
